

CONSENT TO THE PROCESSING OF PERSONAL DATA FOR PARTICIPATION IN THE WORLD ATOMIC WEEK INTERNATIONAL FORUM

By posting my personal data on the websites <https://worldatomicweek.com/>, <https://worldatomicweek.accreditation.ru/>, I hereby give my consent to the Personal Data Operator (hereinafter referred to as the Operator), **A5000 LIMITED LIABILITY COMPANY** (OGRN: 1167746057159, TIN: 7708278895, address of the legal entity: 129329, Moscow, Kolskaya str. Moscow, 7, bldg. 2, floor 1, room I, com 1 (part), 2) for automated (with the help of computer facilities) and non-automated (without the use of computer facilities) processing of the following provided personal data (if provided for in the registration form):

Full name (in Russian and English); citizenship; gender; passport series; passport number; birth certificate series and number; date of birth; place of birth; scanned copy of an identity document; facial photograph; contact phone number; email address; information about country, region, and city of residence; information about place of work/study; job title; field of activity/area of study; organization's TIN (Taxpayer Identification Number); required organizational services; information on actions performed on the website; information on devices used; IP address; cookies; for the purpose of:

- organising my participation in the **WORLD ATOMIC WEEK** International Forum on Atomic and Related Industries (25-28 September 2025, Moscow, VDNKh) (hereinafter referred to as the 'Event');
 - identification, creating an account on the Website and providing access to the content and functionality of the Website: in particular, in order to be registered as a participant of the Event;
 - identifying myself as a participant in the Event and enabling me to provide services related to such events (such as creating and printing badges, issuing passes, booking venues where the events will be held, other similar actions necessary for the proper conduct of the events), as well as for access to the event area (in the case of in-person events);
 - notification and provision of necessary information about the Event and other events (e.g., location, dates, etc.), as well as sending notices and news releases about the Event;
 - organising the Subject's transfer to the venue of the Event;
 - providing the Subject with access to the mobile application of the Event.
1. In the course of processing, the following actions will be performed with personal data: collection, recording, systematisation, accumulation, storage, clarification (updating, modification), extraction, use, transfer (provision, access), badge printing, depersonalisation, blocking, deletion, destruction, transfer of personal data.
 2. Personal data for the purpose of ensuring participation in the Event may be transferred to the following third parties:

- Limited Liability Company "Operator of Interesting Recreation and Travel "Active Krugozor"" (603057 Nizhny Novgorod, Gagarina Avenue, 38 sq. 5) - the Event Operator.

3. This consent shall be valid from the moment of provision and for a period of 30 (thirty) days from the date of achievement of the purposes of personal data processing specified in this consent. Upon expiry of the said period, the personal data shall be destroyed.
4. If I refuse the processing of personal data by metric programmes, I have been informed to stop using the website or to disable cookies in my browser settings.
5. I am aware that the transfer of personal data (granting access) may be terminated at any time at the request of the subject of personal data. This request shall include: surname, first name, patronymic (if any), contact information (telephone number, e-mail address or postal address) of the personal data subject, as well as a list of personal data, the processing of which is subject to termination.
